

## Official Rules

NO PURCHASE OR PAYMENT NECESSARY. PROMOTION IS OPEN TO LEGAL RESIDENTS OF THE CONTINENTAL UNITED STATES AND THE DISTRICT OF COLUMBIA, ENTRANTS MUST BE 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY. VOID WHERE PROHIBITED BY LAW.

PROMOTION PERIOD: The G8Only Corp. Dream Car Giveaway (the "Giveaway") begins at 12:01:00 a.m. Eastern Standard Time ("EST") on Sept 9, 2022 and \*ends at 11:59:59 p.m. EST on October 31, 2022 (the "Promotion Period"). \**Subject to change*

ELIGIBILITY: Open to permanent legal residents of the Continental United States and the District of Columbia, entrants must be 18 years of age or older at time of entry who have a valid driver's license. Void in Puerto Rico & U.S. Territories and where prohibited or restricted by law.
